#### VI. ISSUANCE OF NOTIFICATIONS

- a. Each NoTrespass Noticenust be in writing and specify
  - 1. Thereason for the Notice
  - 2. A description of the specific behavior(s) leading to the Notice
  - 3. Thescope and duration of the rohibition, to include the LSSC propertyr portion of campusthe trespasser is prohibited from entegin
  - 4. The potential consequences of the violation of the prohibition
  - 5. Theappeal avenues (if any) available
- b. The scope, duration, and other stipulations of the The spass Notice nust be proportional to the underlying misconduct and must be narrowdillored to protect the College community from further misconduct.
- c. A temporary NeTrespass notice may be issued for a maximum of 15 **bays** ay be extended for causeduring an orgoingadministrative process.
- d. A temporary NoTrespass Notice will expire no later than
